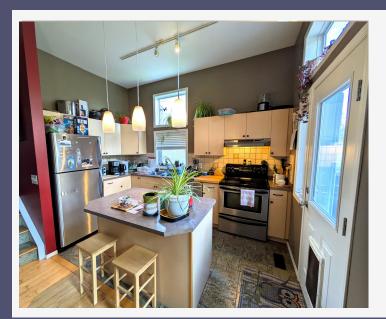
Middle Springs duplex with a legal suite, open-concept layout, and ample storage.

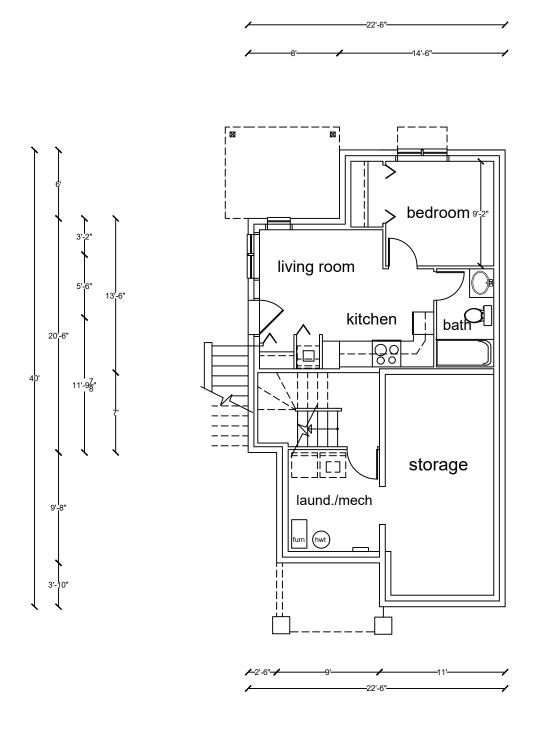

- Replacement of all upstairs carpet (2017).



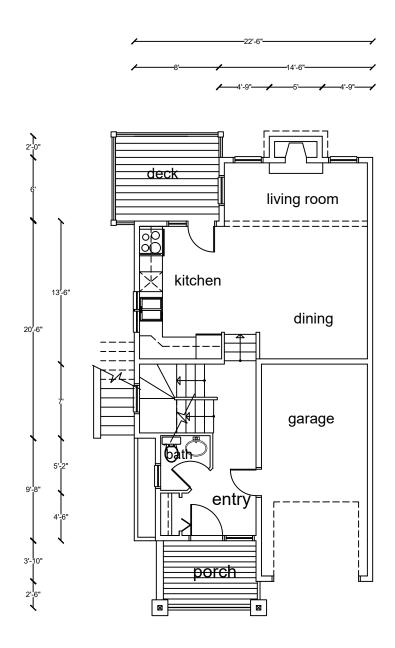
Fees & Utilities

Estimates are based on 5-person occupancy (3 persons main house + 2 persons basement suite).

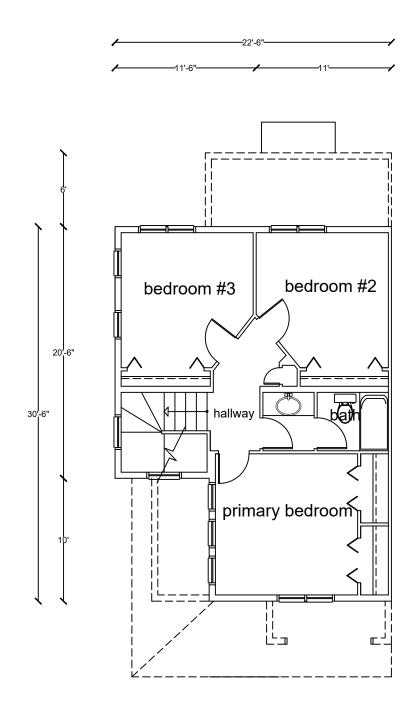
- Gas/electrical \$225 monthly est.
